They show up in governance gaps, staff burnout, undocumented processes, cyber vulnerabilities, safeguarding failures, and incidents no one reported. Your Board reviews the strategic plan and approves the budget. But who is systematically watching the risks?

We build your Enterprise Risk Dashboard — the second governance tool every Board needs. Designed by a former Director at Imagine Canada's Insurance & Liability Resource Centre, our approach provides practical, Board-ready risk oversight for Canadian nonprofits — scaled appropriately to your organization's size.

WHAT IS ENTERPRISE RISK MANAGEMENT?

We don't just list risks — we build an enterprise risk framework. Your key risks are identified, grouped across nine domains, and scored on likelihood, impact, and level of control. Everything connects to one Board-ready scorecard that your leadership team will actually use.

These risks show up in governance practices, staff experience, policies, contracts, insurance coverage, and past incidents. Our risk reviews combine leadership interviews, an anonymous risk survey, and a review of governance documents, policies, insurance, bylaws, committee terms of reference, and key agreements.

Our assessment framework aligns with Canadian nonprofit sector best practices, scaled appropriately for your organization's size and complexity.

- 5. What Your Team Is Really Thinking** — standalone analysis of your anonymous staff, volunteer, and Board member survey results with domain-by-domain breakdown and key themes.
- 6. Board Introduction Session** — a virtual session introducing the ERM Scorecard to your Board, explaining how to use it, and covering risk management principles customized for nonprofit governance.

 - Step 4: Policy & Document Review** (bylaws, procedures, committee terms of reference, insurance, key agreements)
 - Step 5: Best-Practice Mitigation Planning**, heatmap scoring, and assigning risk owners
 - Step 6: Complete Documentation Package** delivered to Executive Director for review over a Zoom call
 - Step 7: Board Introduction Session** to introduce the Board ERM Scorecard and how to use it

OUR NINE ENTERPRISE RISK DOMAINS

We assess risk across nine domains that matter most to nonprofit Boards — from governance and finance to cybersecurity and reputation. Requirements are tailored to your organization’s scale.

1. Governance, Leadership & Strategy

- Board composition, roles, succession, bylaws, committee structure, oversight of strategy and major decisions
“Most boards are working harder than ever — and governing less effectively than they think.”

2. Legal & Regulatory Compliance

- Corporate obligations, employment law, privacy and data protection, accessibility, OH&S, CRA charity requirements (where applicable)
“Policies often exist on paper. Whether they are current, understood, and consistently followed is another question.”

3. Financial Sustainability & Controls

- Structural deficits, revenue concentration, cash flow, budgeting practices, internal controls, fraud exposure, insurance coverage
“One lost grant, one departed major donor, or one uninsured incident can destabilize an organization quickly.”

4. Revenue, Funding & Stakeholder Trust

- Funding models, donor stewardship, restricted fund management, transparency, fundraising activities, revenue diversification
“Trust from funders, donors, and partners takes years to build — and only one mistake to damage.”

5. People, Culture & Workforce

- Staff recruitment, retention, leadership succession, workload and burnout, HR policies, volunteer screening and supervision, safeguarding and psychological safety
“Anonymous staff feedback often reveals risks leadership teams do not fully see.”

6. Programs, Services & Community Impact

- Program-mission alignment, participant/client safety, safeguarding children and vulnerable adults, outcome measurement, complaint and incident reporting, oversight of contracted service providers
“The program that built your reputation five years ago may be your biggest vulnerability today.”

7. Operations, Facilities & Business Continuity

- Key-person dependencies, undocumented processes, operational reliability, health and safety, facilities and leases, vendor relationships, emergency preparedness
“In many organizations, the loss of one or two key people could disrupt operations within weeks.”

8. Digital Systems, Cybersecurity & Data Protection

- Donor, client, and staff data protection, cybersecurity risks (phishing, ransomware), system reliability and backups, vendor and cloud dependencies, responsible use of AI
“Boards often assume their systems are secure — without ever having reviewed them.”

9. Reputation, Partnerships & External Risks

- Relationships with funders, partners, and community stakeholders, public reputation, social media risks, crisis communications preparedness, external policy and regulatory changes
“Most organizations do not think about crisis communications until the day they need it.”

Each domain is translated into clear, Board-ready risk statements, ratings, and mitigation actions on your ERM Scorecard.

HOW ASSESSMENT DEPTH SCALES BY TIER

All organizations are assessed across the same 9 domains.
 What changes is the depth of analysis appropriate to your complexity.

EXAMPLE: GOVERNANCE, LEADERSHIP & STRATEGY

FOUNDATIONS:

Board basics – roles, bylaws, conflict of interest, ED oversight

STANDARD:

+ Committee effectiveness, succession planning, Board evaluation

COMPREHENSIVE:

+ Multi-site governance, complex stakeholder structures, strategic risk alignment

EXAMPLE: PEOPLE, CULTURE & WORKFORCE

FOUNDATIONS:

Key-person risk, basic HR practices, burnout check

STANDARD:

+ Full HR policy review, performance systems, volunteer management

COMPREHENSIVE:

+ Union considerations, multi-location workforce, leadership pipeline analysis

EXAMPLE: DIGITAL SYSTEMS, CYBERSECURITY & DATA PROTECTION

FOUNDATIONS:

Password/access basics, backup practices, data handling essentials

STANDARD:

+ Full cyber risk assessment, vendor security review, AI use policies

COMPREHENSIVE:

+ Multi-system integration risks, advanced incident response planning, third-party security audits
